### Why are we here?

Official social media sites are a "public forum"



#### What is a public forum?

- Government property where speech can be delivered
  - Traditional public forum
  - Limited/designated public forum
  - Non-public forum





## Public Forum Concept Applied to Social Media

"While in the past there may have been difficulty in identifying the most important places (in a spatial sense) for the exchange of views, today the answer is clear. It is cyberspace—the 'vast democratic forums of the Internet' in general, ... and social media in particular."





# How was this applied in California?

- Persons identified themselves as public officials
- Invoked their governmental status to encourage engagement
- Inform the public about events and news concerning the public entity

- James Freed is City Manager of Port Huron, Michigan
  - Picture of himself with a city lapel pin, identifies his title
  - Linked to city's website
  - Uses his email address





- James Freed is City Manager of Port Huron, Michigan
  - Solicited feedback from the public
  - Posted a link of a survey about housing and encouraged people to complete it





- James Freed is City Manager of Port Huron, Michigan
  - Talks about his job
  - Reconstruction of the City's boat launch
  - Streamlining leaf pick-up
  - Stabilizing water intake from the local river





#### Responded to questions

- Both personal and professional
  - Can City's residents be allowed to have chickens?

• Personal and Professional information



#### Kevin Lindke

#### Concerned citizen

- Pandemic responses were "abysmal" and "the City deserves better"
- Commented on picture of City Manager taking out from restaurant





#### Lawsuit

First Amendment Claim

Right to Comment because it was a public forum



## Public Officials Have Rights

Freed did not relinquish his First Amendment rights when he became city manager





#### Rule

- A public official's socialmedia activity constitutes state action only if the official:
  - Possessed actual authority to speak on the State's behalf, and
  - Purported to exercise that authority when he spoke on social media





## **Possessed of State Authority**


- Statute
- Ordinance
- Regulation
- Custom or usage



## Statute, Ordinance & Regulations

#### Must be in writing

• Must be specific





## Custom or Usage

- Persistent practices
  - Doesn't have to be on social media



#### Must be the Cause of the Violation

Limited authority results in limited liability



#### Rule

- A public official's socialmedia activity constitutes state action only if the official:
  - Possessed actual authority to speak on the State's behalf, and
  - Purported to exercise that authority when he spoke on social media





# Purported to exercise that authority

 Exercising responsibility - not merely reporting on it



## Labels Make a Difference

#### Official:

- City Manager of Port Huron
- Mayor of Beverly Hills
- Personal:
  - Personal page of James Freed
  - Personal page of Joe Smith, Mayor of Beverly Hills



## **Council Member Takeaways**

- Indicate that the social media page is not official
  - Personal
  - Link to official page
- If posting about news, be honest
  - City Manager form of government
- City should adopt "official" City pages



## **City Manager Takeaways**

#### Official City Sites

- Clearly posses authority
- Don't use your social media to exercise authority
